

WHEREAS, Investigator Christopher Monico #1368 has filed an Affidavit before the undersigned Judge of the County Court of Lancaster County, Nebraska, a copy of which Affidavit is attached hereto and made a part hereof, the court finds that for purposes of this Order the facts set forth in said Affidavit are true, and said facts and the evidence adduced constitute grounds and probable cause for the issuance of an Order to Produce Identifying Physical Characteristics. The Court further finds and orders as follows:

- That the offenses of Possess Firearm with FEL 2A Drug Violation, 28-416(16), Possess Firearm with FEL 2 Drug Violation, 28-416(16), and Possession of Money to be used Violating 28-416(1), 28-416(17) is the subject of said Affidavit referred to above
- That there is probable cause to believe that the offense of Possess Firearm with FEL 2A Drug Violation, 28-416(16), Possess Firearm with FEL 2 Drug Violation, 28-416(16), and Possession of Money to be used Violating 28-416(1), 28-416(17) has been committed.
- 3. That there is probable cause to believe that Kevin Jarzell Moore committed said offenses.

4. That Identifying Physical Characteristics Sought is/are DNA Characteristics.

- 5. That Kevin Jarzell Moore has refused, or there is reason to believe that Kevin Jarzell Moore will refuse, to voluntarily provide the identifying physical characteristics sought.
- 6. That Kevin Jarzell Moore is the individual who may be detained for obtaining such identifying physical characteristics.
- That Investigator Christopher Monico #1368 and other officers of the Lincoln Police Department are the peace officers authorized to obtain such identifying physical characteristics and to effectuate any detention which may be necessary to obtain the same.
- 8. That Kevin Jarzell Moore will be under no legal obligation to submit to any interrogation or to make any statement during the period of his appearance.

- 10. That Kevin Jarzell Moore shall appear at the Lancaster County Jail, 3801 West O Street, Lincoln, Lancaster County, Nebraska, at such date and time as is designated by Investigator Christopher Monico #1368 for the purpose of obtaining the above-mentioned identifying physical characteristics.
- 11. That if Kevin Jarzell Moore fails to comply with the request of said Investigator Christopher Monico #1368, the said Kevin Jarzell Moore shall be guilty of contempt of court and be punished accordingly.
- 12. That Kevin Jarzell Moore shall be required to stay no longer than one (1) hour for the purpose of Investigator Christopher Monico #1368 obtaining the abovementioned identifying physical characteristics.
- 13. That this Order shall remain in force and effect for a period of fifteen (15) days only.

- 14. That a copy of this Order shall be served upon Kevin Jarzell Moore.
- 15. That a Return of this Order shall be made within 30 days after the identification procedures have been carried out, setting forth the type of identifying physical characteristics obtained. If the Order is not executed, a Return shall be filed within 30 days stating the same.

THEREFORE, you are commanded to search the said Kevin Jarzell Moore to produce the aforementioned identifying physical characteristics which constitutes evidence that a criminal offense has been committed, and to seize the same.

COMES NOW, Investigator Christopher Monico #1368 of the Lincoln Police Department, being first duly sworn upon oath, deposes and states as follows:

- Your AFFIANT was assigned to investigate a Possess Firearm with FEL 2A Drug Violation, 28-416(16), Possess Firearm with FEL 2 Drug Violation, 28-416(16), and Possession of Money to be used Violating 28-416(1), 28-416(17) that occurred at 640 Oregon Trail, Lincoln, Lancaster County, Nebraska.
- Your AFFIANT was involved in the investigation of Possess Firearm with FEL 2A Drug Violation, 28-416(16), Possess Firearm with FEL 2 Drug Violation, 28-416(16), and Possession of Money to be used Violating 28-416(1), 28-416(17) and has conducted additional follow up into the investigation of the incident. According to the information that your AFFIANT obtained:

On 03-09-2023 at approximately 0900 hours, Agents with the US Marshal's Office, Members of the Fugitive Task Force, and Investigators from the Lincoln/Lancaster County Narcotics Task Force were at 640 Oregon Trail, Lincoln, Lancaster County, Nebraska, looking for Kevin Jarzell Moore. Kevin Jarzell Moore had an active felony warrant for his arrest, reference an Assault by Strangulation case. Agents had received information that Kevin Jarzell Moore was at his residence at 640 Oregon Trail. Agents set up a perimeter around the residence and witnessed a party attempt to flee out of the rear (North) door of the residence. Agents knocked and announced their presence for the next

the upstairs living room couch, but admitted he was the person witnessed peeking out of the eastside basement bedroom window. Jazire Jaquan C. Moore denied destroying evidence, but giggled about a mystery person doing it and then flying into the air, away from the residence.

Jazire Jaquan C. Moore was taken into custody at approximately 1025 hours and transported to the Lancaster County jail for Tampering with Physical Evidence, 28-922.

Your Affiant drafted a search warrant for 640 Oregon Trail. Investigators from the Lincoln/Lancaster County Narcotics Task Force executed this search warrant at 1335 hours. Investigators located a total of 849.9 grams of marijuana, 53 – THC vape cartridges/vape pens, 737 bullets (.22, 9mm, and .380 calibers), 3.5 grams of suspected cocaine, numerous self-seal baggies and vacuum seal bags (of various sizes) that contained either marijuana residue or suspected cocaine residue, and a total of \$1994 dollars of US currency. Investigators know that these quantities of drugs are not personal user amounts.

The upstairs middle hallway bedroom was determined to belong to Kevin Jarzell Moore. Investigators located IRS paperwork with Kevin Jarzell Moore's name on it, in the bedroom closet. Investigators located two stolen handguns in Kevin Jarzell Moore's bedroom. Under a pillow, on Kevin Jarzell Moore's bed, Investigators located a loaded turquoise/stainless SCCY 9mm semi-auto handgun, serial #671104. That gun was reported stolen to the Omaha Police Department, case #AP21887. The second stolen gun was located in the bedroom closet and was a loaded Sig Sauer 1911 .22 caliber semi-auto handgun, serial #F163670. That gun was reported stolen to the Lincoln Police Department, on 01-27-2017, case #B7-007545.

From the total amounts listed above, specific items located in Kevin Jarzell Moore's upstairs bedroom included: a baggie of 128.2 grams of marijuana, a baggie of 24.4 grams of marijuana, a baggie of 9.1 grams of marijuana, a baggie of 1.1 grams of marijuana, a baggie of 3.5 grams of suspected cocaine, a black/silver digital scale with residue, 737 bullets (.22, 9mm, and .380 calibers), \$469 dollars of US Currency, and multiple baggies that contained suspected cocaine residue. Possession of Money to be used Violating 28-416(1), 28-416(17) as described herein, and in violation of the laws of the State of Nebraska.

3. Your AFFIANT has been advised that Kevin Jarzell Moore's attorney has been asked to speak with his client, Kevin Jarzell Moore, about giving consent to providing a DNA sample via buccal swabs. Kevin Jarzell Moore's attorney has not responded since being emailed on 01-19-2024.

Further your affiant saith not.
