Joseph Fisher, being first duly sworn upon oath deposes and states that he is a Police Officer for the Lincoln Police Department, Lancaster County, Nebraska. AFFIANT further states he is currently involved in the investigation of City Ordinance 10.42.110 Keeping of unregistered, wrecked or junked vehicles, occurring at 5242 Stockwell St, Lincoln, Lancaster County, Nebraska.

**Facts**

On December 13, 2023, Lincoln Police Department Public Service Officer Michael Schaaf #764 was detailed 5242 Stockwell St., Lincoln, Lancaster County, Nebraska on a complaint regarding a junk vehicle, a white 2006 Mercedes with no license plate partially covered by a tarp, that was parked to the north of the residence. PSO Schaaf made contact with Timothy Beenblossom, a resident of this address. Beenblossom told PSO Schaaf the vehicle belonged to him. Beenblossom was provided information as to the complaint and ways to remedy it. Beenblossom was given a compliance date of January 13, 2024. On January 18, 2024, PSO Schaaf and Ofc. Estrada #1812 went to 5242 Stockwell St., Lincoln, Lancaster County, Nebraska and contacted Beenblossom. The white Mercedes was still on the property in the same condition it was on December 13, 2023. Beenblossom said he was still trying to sell the vehicle. Beenblossom was cited for Keeping of Unregistered, Wrecked or Junked Vehicles.

On January 20, 2024, your Affiant went to the address at 5242 Stockwell St. and observed the white 2006 Mercedes to still be on the property partially covered by a tarp in the backyard.

Your Affiant checked on Channel 16 (Police information) and learned that no hobbyist permits have been issued to ~~Roger~~ or to the address of 5242 Stockwell St.
