ORDER TO PRODUCE IDENTIFYING PHYSICAL CHARACTERISTICS

DAEJON L. COLLINS,

TO: Eric Dlouhy badge 1623, and other law enforcement officers of the Lincoln Police Department

WHEREAS, Eric Dlouhy has filed an Affidavit before the undersigned Judge of the County Court of Lancaster County, Nebraska, a copy of which Affidavit is attached hereto and made a part hereof, the court finds that for purposes of this Order the facts set forth in said Affidavit are true, and said facts and the evidence adduced constitute grounds and probable cause for the issuance of an Order to Produce Identifying Physical Characteristics. The Court further finds and orders as follows:

- 1. That the offense of 3rd degree domestic assault and terroristic threats is the subject of said Affidavit referred to above
- 2. That there is probable cause to believe that the offense of 3rd degree domestic assault and terroristic threats has been committed.
- 3. That there is probable cause to believe that Daejon Collins committed said offense.
- 4. That Identifying Physical Characteristics Sought is/are DNA buccal swabs.
- 5. That Daejon Collins has refused, or there is reason to believe that Daejon Collins will refuse, to voluntarily provide the identifying physical characteristics sought.
- 6. That Daejon Collins is the individual who may be detained for obtaining such identifying physical characteristics.
- 7. That Eric Dlouhy and other officers of the Lincoln Police Department are the peace officers authorized to obtain such identifying physical characteristics and to effectuate any detention which may be necessary to obtain the same.
- 8. That Daejon Collins will be under no legal obligation to submit to any interrogation or to make any statement during the period of his appearance.

- 9. That such identifying physical characteristics may be obtained at the Lancaster County Jail 3801 West O Street Lincoln, Lancaster County, Nebraska.
- 10. That Daejon Collins shall appear at the Lancaster County Jail 3801 West O Street, Lancaster County, Nebraska, at such date and time as is designated by Eric Dlouhy for the purpose of obtaining the above-mentioned identifying physical characteristics.
- 11. That if Daejon Collins fails to comply with the request of said Eric Dlouhy, the said Daejon Collins shall be guilty of contempt of court and be punished accordingly.
- 12. That Daejon Collins shall be required to stay no longer than one (1) hour for the purpose of Eric Dlouhy obtaining the above-mentioned identifying physical characteristics.
- 13. That this Order shall remain in force and effect for a period of fifteen (15) days only.
- 14. That a copy of this Order shall be served upon Daejon Collins.
- 15. That a Return of this Order shall be made within 30 days after the identification procedures have been carried out, setting forth the type of identifying physical characteristics obtained. If the Order is not executed, a Return shall be filed within 30 days stating the same.

THEREFORE, you are commanded to search the said Daejon Collins to produce the aforementioned identifying physical characteristics which constitutes evidence that a criminal offense has been committed, and to seize the same.

AFFIDAVIT FOR
ORDER TO PRODUCE IDENTIFYING
PHYSICAL CHARACTERISTICS

COMES NOW, Investigator Eric Dlouhy badge 1623 of the Lincoln Police Department, being first duly sworn upon oath, deposes and states as follows:

- 1. Your AFFIANT was assigned to investigate a domestic assault that occurred at 2120 North 70th Street in Lincoln, Lancaster County, Nebraska.
- 2. Your AFFIANT has reviewed reports of other peace officers involved in the investigation of 3rd degree domestic assault and terroristic threats and has conducted additional follow up into the investigation of the incident. According to the information that your AFFIANT obtained:

On March 1, 2024, at 4:21 A.M. Officer Hyland badge 1857 and other Lincoln Police Officers were dispatched to 2120 North 70th Street on a domestic assault report. Courtney Thomas called 911 stating that her ex-boyfriend and father of her children, Daejon Collins, was at her residence with a gun and threatening to kill her. Your Affiant listened to the 911 call and a male that Courtney stated is Daejon is heard threatening to kill Courtney. Officers arrived at approximately 4:24 A.M. and observed Daejon in the front yard of 2120 North 70th Street. Daejon ran into a Black 2006 Black Chevrolet Trailblazer Nebraska license plate number YVA155 and was given multiple commands to stop the vehicle at gunpoint. Daejon refused to do so and fled northbound in the vehicle towards Adams at a high rate of speed. Daejon lost control of the vehicle due to his reckless driving behavior immobilizing it just north of the intersection of North 70th and Adams Street. Daejon then fled the accident on foot from the vehicle, running through yards between North 68th to 70th Street, just north of Adams Street. Daejon continued fleeing, resisting arrest and apprehension from Officers for approximately ten minutes, when he was stopped in the driveway of 3020 North 68 Street and taken into custody.

Courtney stated she and Daejon were previously in a relationship for ten years, with three shared children between them, D.C, D.C, and C.C. Courtney stated they broke up in 2022 and had been in an on and off again relationship since. Courtney reported an argument started at 4311 Starr Street in Lincoln, Lancaster County, Nebraska at approximately 2:00 A.M. regarding Daejon's windshield being broken. Courtney stated she was assaulted during this incident which is documented under Lincoln Police Department case number C4-018177 by Daejon and Jayveona Lipscomb, his current girlfriend. Courtney reported Daejon pinned her down inside the residence while Jaeveona punched her in the back of the head 6-7 times causing pain and injury. Courtney had a 1 to 2 inch laceration on the bridge of her nose, a swollen and red contusion just above her right temple, a swollen and red contusion on the top right side of her head. Courtney stated Daejon said, "why you hitting yourself?" after each punch until he ultimately stopped Jaeveona. Courtney advised that as she was leaving Jaeveona threw bricks, a shovel, and sticks at her. However, none of the objects struck her. Courtney stated Daejon later went to her residence to confront her about the broken windshield. Courtney denied ever striking Daejon's vehicle stating it was likely done by Jaeveona as she threw the objects.

Courtney then returned home, and Daejon arrived shortly thereafter. Courtney stated Daejon broke the rear windshield of her vehicle with the handgun he had on him in an act of revenge as he blamed Courtney for his broken windshield. This caused approximately \$400 worth of damage to the window. Courtney described the handgun as a black revolver or similar. Courtney stated she called 911, and then Daejon turned his attention toward her. Daejon confronted Courtney at the front door of her residence, screaming so loud, waking up all three children sleeping in the home. The children then came to the living room and sat on the couch. Courtney reported Daejon then pulled a gun from his rear waistband, cocked it back and pointed it at Courtney's feet. Daejon reportedly stated, "You did this to me!", "You know I shouldn't be here!", "I'll blow this whole shit up". All three children were sitting on the couch and witnessed Daejon pull the gun and threaten them. Courtney stated she was in fear for her life and their children's. Courtney attempted to close the door and Daejon kicked it, preventing the door from closing. Courtney stated Daejon then turned and pointed the gun at Officers inside the marked police cruisers as they arrived.

A search of Daejon's vehicle was conducted and a Black Smith and Wesson 40mm semi-automatic pistol serial number DVN7447 was located by Officer Lancaster badge 1938 in the front passenger's door pocket. The gun was loaded with 10 rounds in the magazine and 1 loaded in the chamber. Also located in the vehicle was a clear plastic bag containing a white powder substance that pretested positive for cocaine.

Daejon made admissions to consuming alcohol and made several unsolicited comments to Officers regarding the night's events. Daejon stated he was not assaulted by Courtney in any way and admitted to being angry with her. Daejon was read and invoked Miranda. Daejon submitted to a Datamaster test at the Lancaster County Jail 3801 West O Street, which provided a BAC of .104 at 6:52 A.M.

On March 5, 2024, at 9:58 A.M. your Affiant spoke with Courtney who stated that Daejon had been texting her after she was assaulted at 4311 Starr Street. Daejon messaged something similar to how Courtney got her ass beat.

The handgun was collected as evidence and placed in the Lincoln Police Department's property unit under property number Q2404004. The ammunition is under property number Q2404005.

Daejon had his black iPhone with him during his arrest. This phone was collected as evidence and placed in the Lincoln Police Department's property unit under property number Q2404017.

On March 5, 2024, at 9:20 A.M. your Affiant contacted Daejon at the Lancaster County Jail. Daejon refused to provide a voluntary sample of his DNA.

3. Your AFFIANT knows that buccal DNA swabs are a way of producing non-testimonial identification evidence regarding the person responsible for the 3rd degree domestic assault and terroristic threats described herein. The identifying physical characteristics sought from Daejon Collins is a sample of his DNA in the form of DNA buccal swabs. The procurement of these identifying physical characteristics is likely to contribute evidence to the further identification of Daejon Collins as being the person responsible for the domestic assault and terroristic threats herein.

The identifying physical characteristics sought can be obtained from Daejon Collins at the Lancaster County Jail 3801 West O Street Lincoln, Lancaster County, Nebraska and should require a detention not to exceed one (1) hour.

AFFIANT further states that there is probable cause to believe that Daejon Collins is responsible for the 3rd degree domestic assault and terroristic threats as described herein, and in violation of the laws of the State of Nebraska.

4. Your AFFIANT has been advised by Daejon Collins that he has refused to voluntarily provide a DNA sample via buccal swabs.
