

ORDER TO PRODUCE IDENTIFYING PHYSICAL CHARACTERISTICS

FREDTADRÍCK KENNEDY DOB 11-04-1995,

TO: Kevin Meyer, and other law enforcement officers of the Lincoln Police Department.

WHEREAS, Kevin Meyer has filed an Affidavit before the undersigned Judge of the County Court of Lancaster County, Nebraska, a copy of which Affidavit is attached hereto and made a part hereof, the court finds that for purposes of this Order the facts set forth in said Affidavit are true, and said facts and the evidence adduced constitute grounds and probable cause for the issuance of an Order to Produce Identifying Physical Characteristics. The Court further finds and orders as follows:

- 1. That the offense of Possession of a Firearm with a Felony 2 Drug Violation 28-416(16) is the subject of said Affidavit referred to above.
- 2. That there is probable cause to believe that the offense of Possession of a Firearm with a Felony 2 Drug Violation 28-416(16) has been committed.
- 3. That there is probable cause to believe that Fredtadrick Kennedy committed said offense.
- 4. That Identifying Physical Characteristics Sought are DNA Buccal swabs.
- 5. That Fredtadrick Kennedy has refused to voluntarily provide the identifying physical characteristics sought.
- 6. That Fredtadrick Kennedy is the individual who may be detained for obtaining such identifying physical characteristics.
- 7. That Investigator Meyer and other officers of the Lincoln Police Department are the peace officers authorized to obtain such identifying physical characteristics and to effectuate any detention which may be necessary to obtain the same.

- 8. That Fredtadrick Kennedy will be under no legal obligation to submit to any interrogation or to make any statement during the period of his appearance.
- 9. That such identifying physical characteristics may be obtained in the city of Lincoln, Lancaster County, Nebraska.
- 10. That Fredtadrick Kennedy shall appear in the city of Lincoln, Lancaster County, Nebraska, at such date and time as is designated by Investigator Meyer for the purpose of obtaining the above-mentioned identifying physical characteristics.
- 11. That if Fredtadrick Kennedy fails to comply with the request of said Investigator Meyer, the said Fredtadrick Kennedy shall be guilty of contempt of court and be punished accordingly.
- 12. That Fredtadrick Kennedy shall be required to stay no longer than one (1) hour for the purpose of Investigator Meyer obtaining the above-mentioned identifying physical characteristics.
- 13. That this Order shall remain in force and effect for a period of fifteen (15) days only.
- 14. That a copy of this Order shall be served upon Fredtadrick Kennedy.
- 15. That a Return of this Order shall be made within 30 days after the identification procedures have been carried out, setting forth the type of identifying physical characteristics obtained. If the Order is not executed, a Return shall be filed within 30 days stating the same.

THEREFORE, you are commanded to search the said Fredtadrick Kennedy to produce the aforementioned identifying physical characteristics which constitutes evidence that a criminal offense has been committed, and to seize the same.

AFFIDAVIT FOR

ORDER TO PRODUCE IDENTIFYING
PHYSICAL CHARACTERISTICS

FREDTADRICK KENNEDY DOB 11-04-1995,

COMES NOW, Investigator Kevin Meyer of the Lincoln Police Department, being first duly sworn upon oath, deposes and states as follows:

- 1. Your AFFIANT was assigned to investigate the crime of Possession of a Firearm with a Felony 2 Drug Violation 28-416(16) that occurred in the city of Lincoln, Lancaster County, Nebraska.
- 2. Your AFFIANT has reviewed reports of other peace officers involved in the investigation of Possession of a Firearm with a Felony 2 Drug Violation 28-416(16) and has conducted additional follow up into the investigation of the incident. According to the information that your AFFIANT obtained:

Beginning in April 2023, Lincoln Police Investigators began to conduct surveillance on the occupants of 1900 Knox Street #24, Lincoln, NE regarding controlled substances being sold from the residence. Investigators learned that Fredtadrick Kennedy (male, DOB 11-04-1995) resided at the residence. Investigators observed Kennedy coming and going from the apartment on multiple occasions. In addition, LES utilities for the apartment were confirmed to be in Kennedy's name.

The Lincoln Police Department Narcotics Task Force investigated a narcotics overdose case occurring in Lincoln, NE. The victim reported they purchased opioid pills from Anthony Gilmore (male, DOB 01-20-1976) and Gilmore's source for those pills was his cousin, Kennedy. The victim later

victim then began purchasing opioid pills directly from Kennedy (documented in case C3-044565). Between May 30, 2023 and June 7, 2023 an undercover Gilmore. A silver Ford Fusion WLW792 arrived, being driven by a party matching Kem1edy's description. The vehicle is registered to T (female, DOB 06-01-1902) Lincoln Police Department officer purchased opioid pills from Gilmore. On one occasion Gilmore told the officer he was waiting for his 'cuz' to bring the pills to matching Kem1edy's description. The vehicle is registered to Latikka Moore officer's \$120 and briefly met with the driver of the Fusion. Gilmore then delivered 5 Oxycodone Hydrochloride pills to the undercover officer.

identified Kennedy from a photograph provided by Investigator Dalton. The

During the next delivery, the undercover officer met with Gilmore and gave him \$160. The Ford Fusion arrived and was being driven by the same individual as the previous delivery. Gilmore briefly got into the Fusion, then delivered 5 Oxycodone Hydrochloride pills and 2 Acetaminophen and Hydrocodone Hydrochloride to the undercover officer.

During the next delivery, the undercover officer ordered pills from Gilmore. Gilmore told the officer to come meet him and that his source was also enroute to the meeting. Investigators identified Kennedy leaving his residence of 1900 Knox St. #24 in the Ford Fusion and meeting with Gilmore and the undercover officer. Gilmore delivered 5 Oxycodone Hydrochloride pills and 8 Acetaminophen and Oxycodone Hydrochloride pills to the undercover officer for \$220.

Investigators observed Kennedy to advertise THC products for sale on social media that are not legal in Nebraska. The social media account has been verified as belonging to Kennedy by Investigator Villamonte.

On 06-13-2023, Investigators served a Lancaster County search warrant at the residence of 1900 Knox St. #24 for narcotics and firearms. Investigators located 3 Live Resin Jeeter Juice THC products, a loaded black Glock 9mm handgun with an extended magazine, \$320 dollars/U.S. Currency, digital scales, 87+grams of marijuana, and 9 blue pills marked 'M30' suspected to be Oxycodone Hydrochloride in and around a black dresser in the master bedroom of the apartment. In this location was a Caesars reward card with Kennedy's name

on it. The THC products were the same products Kennedy was advertising for sale on his social media account being monitored by Investigator Villamonte on the same date. The pills matched the description of those purchased by the undercover police officer on the previous buys.

Investigators know through extensive investigative experience that firearms, currency, and controlled substances are commonly possessed together during a drug sales operation with the firearm being a means to protect profits and product from theft.

A warrant was issued for Kennedy's arrest pertaining to the aforementioned investigation. Kennedy was located in the City of Lincoln on 07-14-2023 and arrested. Kennedy declined to participate in a Miranda interview or speak with Investigators.

On 02-20-2024, your AFFIANT contacted Kennedy at 10th Street and South Street, Lincoln, Lancaster County, Nebraska and asked for his consent to voluntarily provide a sample of his DNA. Kennedy denied consent but stated he would be cooperative with providing his DNA once a DNA order was issued

3. Your AFFIANT knows that buccal DNA swabs are a way of producing non-testimonial identification evidence regarding the person responsible for the Possession of a Firearm with a Felony 2 Drug Violation - 28-416(16) described herein. The identifying physical characteristics sought from Fredtadrick Kennedy is a sample of his DNA in the form of DNA buccal swabs. The procurement of these identifying physical characteristics is likely to contribute evidence to the further identification of Fredtadrick Kennedy as being the person responsible for the Possession of a Firearm with a Felony 2 Drug Violation - 28-416(16) herein.

The identifying physical characteristics sought can be obtained from Fredtadrick Kennedy in the city of Lincoln, Lancaster County, Nebraska and should require a detention not to exceed one (1) hour.

AFFIANT further states that there is probable cause to believe that Fredtadrick Kennedy is responsible for Possession of a Firearm with a Felony 2 Drug Violation - 28-416(16) as described herein, and in violation of the laws of
