Your Affiant, respectfully submits this ex parte application for a court order pursuant to Neb. Rev. Stat. sec 86-2,106 and 18 U.S.C. § 2703(d) to require AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON), Electronic Communication Service Providers, which function as electronic communication service providers and/or a remote computing service, to provide records and other information of wire or electronic communications pertaining to data held by Cell Sites serving the area at, and immediately surrounding the physical address(s) described in Attachment A. In support of this application, the State of Nebraska asserts:

#### LEGAL AND FACTUAL BACKGROUND

Your Affiant is employed by the, Lincoln Police Department, a law enforcement agency, is acting on behalf of the governmental entity, while investigating a Fleeing to Avoid Arrest, Criminal Mischief and Willful Reckless Driving occurring at the physical address(s) of 1840 Knox, Lincoln, Lancaster County Nebraska, as described in Attachment A.

Investigation to date provides reasonable grounds to believe that AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON) has records and other information pertaining to certain subscribers that are relevant and material to an ongoing criminal investigation. Because AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and

VERIZON VSAT (VERIZON) function as electronic communication service providers (provides its subscribers access to electronic communication services, including email and the Internet) and/or a remote computing service (provides computer facilities for the storage and processing of electronic communications), Neb. Rev. Stat. sec 86-2,106 and 18 U.S.C. § 2703 set out particular requirements that a governmental entity must meet in order to obtain access to the records and other information it is seeking.

Here, the governmental entity seeks to obtain the following information: stored electronic communication records and other information (not including the contents of communications) pertaining to certain subscribers of AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON).

To obtain records and other information (not including the contents of communications) pertaining to subscribers of an electronic communication service provider or remote computing service, the governmental entity must comply with Neb. Rev. Stat. sec 86-2,106 and 18 U.S.C. § 2703(c). Section 86-2,106 provides, in pertinent part: A governmental entity may require a provider of electronic communication service or remote computing service to disclose a record or other information pertaining to a subscriber to or customer of such service (not including the contents of communications) only when the governmental entity obtains a court order for such disclosure under subsection (4) of this section.

Section 2703(d), in turn, provides in pertinent part: A court order for disclosure under subsection (b) or (c) may be issued by any court that is a court of competent jurisdiction, defined pursuant to 18 U.S.C. § 2711(3) as: (3) the term "court of competent jurisdiction" has the meaning assigned by section 3127, and includes any Federal court within that definition, without geographic limitation 18 U.S.C. §3127 defines court of competent jurisdiction as: (B) a court of general criminal jurisdiction of a State authorized by law of that State to enter orders authorizing the use of a pen register or a trap and trace device.

A court order shall issue only if the governmental entity offers specific and articulable facts showing that there are reasonable grounds to believe that the records or other information sought are relevant and material to an ongoing criminal investigation. A court issuing an order pursuant to this section, on a motion made promptly by the service provider, may quash or modify such order, if the information or records requested are unusually voluminous in nature or compliance with such order otherwise would cause an undue burden on such provider.

Accordingly, this application sets forth specific and articulable facts showing that there are reasonable grounds to believe that the records sought are relevant and material to an ongoing criminal investigation.

#### THE RELEVANT FACTS

On Sunday 12-17-23, at approximately 0939 hours, Officer Kernan was on patrol and conducted a traffic stop on a white Hyundai Azera with no license plates. The traffic stop was initiated in the area of 19th/Knox Streets in Lincoln, Lancaster County, Nebraska. The offender vehicle stopped in a parking stall at the Willow Apartment Complex. Prior to officer Kernan making contact with the driver, the vehicle fled in a NB direction in the parking lot squealing the tires as it accelerated. Officer Kernan followed the vehicle which came to a dead end. The white Hyundai backed up quickly causing the vehicle to travel over the top of a retaining wall where it struck the top of a parked vehicle that was parked in an adjacent apartment complex below the retaining wall. Officer Kernan exited his cruiser drawing his firearm and began to approach the offender vehicle. While approaching the vehicle the suspect accelerated quickly squealing the tires and going forward in the direction of Officer Kernan. Officer Kernan fired two shots from his handgun at the vehicle as it accelerated and fled the area without being located.

Investigators used the in car camera from Kernan's cruiser to identify the make and model of the vehicle. There were also unique markings on the suspect vehicle that would help identify it. On 12-17-23, at 2213 hours Officer Covault located the suspect vehicle parked and unoccupied on Manatt Street between 8th-9th Streets. The vehicle was identified as the suspect vehicle and had in-transit tags in the window showing it was purchased at George's Auto and the purchaser's name listed as B. Blazio.

Officers obtained surveillance video from a couple homes along Manatt St showing the suspect vehicle parking there approximately 2-3 minutes after it fled the traffic stop. The driver is seen exiting the vehicle and running towards another vehicle that arrived in the area. The suspect was a light skinned male wearing red shorts, black T-shirt, and black slides/slip on sandals. The suspect was also wearing his hair tied up in a bun in the back. The suspect vehicle was towed to the impound lot located at 101 Charleston St., Lincoln, Lancaster County, Nebraska and is being held as evidence. Officers located 2 bullet holes in the hood of the vehicle and damage to the back driver side where it collided with the parked vehicle which confirms this was the same vehicle that fled from Officer Kernan.

During further investigation, officers determined the vehicle was purchased by Braulio Blazio on 12-09-23 from George's Auto located at 1500 Cornhusker Highway, Lincoln, Lancaster County, Nebraska. Video surveillance was obtained from George's and shows Braulio Blazio with his hair tied up in a bun in the back also wearing black sides that are seen on the suspect. The vehicle that was struck during the reckless flee to avoid arrest sustained significant damage but is valued at less than \$5,000. It is described as a Grey 2008 Nissan Rouge and sustained approximately \$2,500 damage.

Your Affiant knows that wireless cellular telephone services in the Lancaster County area are provided primarily by 4 separate cell phone service providers: AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON

VSAT (VERIZON). Affiant knows that each of these providers maintains numerous cellular towers in various locations throughout the area, and that these towers are identifiable by physical address and geographical coordinates (latitude/longitude). Affiant knows that tower analysis can be conducted to determine what cell phones/smart phones registered on various cell towers on a specified date at a specified time frame. Affiant also knows that each provider maintains access data for each tower and each sector for a variety of purposes including customer service, for network operation/maintenance, to comply with federal regulations, and that such data is available for an extended period of time often up to one year.

Whenever a cellular telephone is in the 'on' condition, regardless of whether it is making or receiving a voice or data call, it periodically transmits a unique identification number to register its presence and location in the network. That signal, as well as calls made from the cellular phone are received by every antenna tower within range of the device.

Affiant knows that obtaining a 'tower dump' of all wireless access data will show all wireless activity occurring on each tower. By completing a 'tower dump' for each of the Cell Sites providing network coverage in the area at and immediately surrounding the physical address(s) described in Attachment A during the date and time frames of the investigation, there is a possibility that if any witnesses or the suspect(s) used their cell phone their number will be captured in the 'tower dump' records, although only in the form of a cellular telephone number. Affiant intends to compare all tower data in an effort to provide information on additional witnesses or suspects.

Affiant further knows that the cell phone service providers also maintain all subscriber information for each such number identified, and that obtaining name and address information will allow for further investigation that will aid in the inclusion or elimination of potential witnesses or suspects.

Affiant also knows that the providers likewise can provide call detail records for those individual numbers that contain information for incoming and outgoing telephone calls, time of call, duration of call, and additional cellular tower information. Forensic analysis of these transactional records can illustrate locations, times, and critical communication information, and are especially valuable in tracking movements of potential suspects prior to, during, and after crimes are committed.

Affiant believes such forensic analysis will identify specific numbers about which additional information will be wanted, and that such information should be provided upon request of the Lincoln Police without necessity of further Court Orders.

Affiant knows that most recent case law has distinguished this type of information as 'transactional' in nature as it is maintained by and for the provider, with little expectation of privacy for the subscriber (as opposed to 'content' type information such as text messages, voicemail, and/or email transmissions in which the subscriber would have a

#### greater expectation of privacy).

Affiant believes a time period identified in Attachment A should be sufficient for this purpose and will provide significant information as to the identity of additional witnesses or a potential suspect in this case.

The details above provide specific and articulable facts to believe that the records sought are relevant and material to an ongoing criminal investigation.

Records of customer and subscriber information relating to this investigation that are available from AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON), and the electronic communications that may be found at AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON), will help investigators to identify any witnesses to the events under investigation, may lead to the individual(s) who are responsible for the events described above, and will assist in determining the nature and scope of their activities. Accordingly, this is a request that AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON) be directed to produce all records described in Attachment A to the proposed Order. Part A of the Attachment requests the subscriber name, user name, address, telephone number, email address, billing information, local & long distance telephone toll billing records, records of session times & durations, length of service (including start date), cell site/sector information, types of services utilized, telephone and/or instrument number, subscriber number or identity, temporarily assigned network address such as Internet Protocol address, and other identifying information.

Information obtained from the service provider for the subscriber that identifies any other person, device, computer, and/or number that is in communication with the subscriber shall be considered part of the criminal investigation. Your Affiant is requesting a court order to compel the disclosure of the subscriber information for that person, device, computer, and/or number to the extent of the data requested in Attachment A from any provider of electronic communication service such as: AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON) by computer search, and its production should not prove to be burdensome.

Your Affiant further requests that AT&T GLOBAL LEGAL DEMANDS CENTER (AT&T), T-MOBILE, US CELLULAR, and VERIZON VSAT (VERIZON) be ordered not to notify any person (including the subscriber or customer to which the materials relate) of the existence of the court's order for such period as the court deems appropriate. Such an order is justified because notification of the existence of the court order would seriously jeopardize the ongoing investigation. Such a disclosure would give the subscriber an opportunity to destroy evidence, change patterns of behavior, notify confederates, or flee or continue his flight from prosecution.


