TO: Garret Meyer, a Police Officer with the Lincoln Police Department, Lancaster County, Nebraska, and any and all law enforcement officers.

WHEREAS, Garret Meyer, has filed an Affidavit before the undersigned Judge of the County Court of Lincoln, Lancaster County, Nebraska, and said written Affidavit, having been duly considered, the court finds that the facts set forth in said Affidavit are true, and that those facts do constitute grounds and probable cause for the issuance of a Search Warrant.

THEREFORE, you are commanded to search 3147 North Hill Road #207, Lincoln, Lancaster County, Nebraska. 3147 North Hill is a building that runs southwest to northeast in the southeastern portion of an apartment complex known as the 'Waterbrook Apartments'. Building '3147' is on the northeastern portion of the building and is denoted by a sign displaying the numbers next to a stairwell that leads to apartment #207 which is located on the second floor of the building in the northeast corner of the building. Apartment #207 is marked with '207' in gold lettering on a maroon door. 3147 North Hill Road #207, Lincoln, Lancaster County, Nebraska, should be searched for the following items:


- Cutting Instruments to include knives or other objects/tools capable of causing a penetrating stab wound
- Blood and other biological evidence and any items containing blood or biological evidence
- Any and all controlled substance, including but not limited to substances believed to be marijuana; drug paraphernalia items commonly used for the ingestion of controlled substances.
- Proof of occupancy

Your AFFIANT is authorized to measure, photograph, video tape, and seize the aforementioned items.

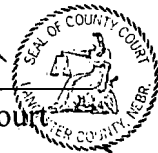
Night time is upon us and the public interest requires that the requested search warrant not be restricted to daytime service and that it may be served at any time.


This search warrant shall be executed and returned within ten (10) days to a Judge of the County Court of Lancaster County, Nebraska.

Garret Meyer #1940, being first duly sworn upon oath deposes and states that he is a Police Officer for the Lincoln Police Department, Lancaster County, Nebraska. AFFIANT further states he is currently involved in the investigation of 2nd Degree Assault 28-309 (F3), occurring at 3147 North Hill Rd #207, Lincoln, Lancaster County, Nebraska. As part of the investigation, AFFIANT has consulted with other involved law enforcement and reviewed case reports. AFFIANT states as follows:

Facts:

On 04-10-2024 at approximately 0131 hours your Affiant and Officers of the Lincoln Police Department were dispatched to 3147 North Hill Rd #207, Lincoln, Lancaster County, Nebraska on a stabbing call for service. Upon your Affiant's arrival a male yelling could be heard from the second floor of the building. Your Affiant contacted the residents inside #207. Megan K Garrow, 06-26-1993, was contacted at the door. Shortly after this Megan informed your Affiant that Brice O Berry, 10-03-1988, was stabbed. Brice then came to the door holding his midsection. Your Affiant observed one puncture wound to Brice's abdominal area. During a safety sweep of 3147 North Hill Rd #207 your Affiant observed blood evidence on the kitchen floor and on the stove. There were blood drops on the floor, and some of the blood was smeared on the floor. There was also a knife with a black handle and silver blade on the floor near the kitchen table just outside of the kitchen. There was also a clear plastic bag which contained a substance believed to be marijuana on the kitchen table. The suspect, Brittany A Borrell 11-13-1985, was located in a vehicle outside the residence. She was placed into custody as Megan and Brice both made statements of her being the person responsible for the stabbing.

3147 North Hill Rd #207 is a known residence for Megan and Brice. Consent to search the premises was denied.

Your AFFIANT is authorized to measure, photograph, video tape and seize the aforementioned items.




Your Affiant states that it is approximately 2:45 a.m. at the time that this Affidavit for Search Warrant is being drafted. Night time is upon us and the public interest requires that the requested search warrant not be restricted to daytime service and that it may be served at any time for the following reasons: A violent crime has just occurred and the blood evidence observed during the protective sweep can dissipate or dry with time. This delay may prohibit law enforcement from determining where in the apartment the stabbing took place. Further, there are occupants of the apartment who have not been arrested and if they are allowed into the apartment they could tamper with or remove evidence.
