TO: Jerad McBride, and other law enforcement officers of the Lincoln Police Department

WHEREAS, Jerad McBride has filed an Affidavit before the undersigned Judge of the County Court of Lancaster County, Nebraska, a copy of which Affidavit is attached hereto and made a part hereof, the court finds that for purposes of this Order the facts set forth in said Affidavit are true, and said facts and the evidence adduced constitute grounds and probable cause for the issuance of an Order to Produce Identifying Physical Characteristics. The Court further finds and orders as follows:

1. That the offense of a terroristic threats and possession of firearm by prohibited person is the subject of said Affidavit referred to above.
2. That there is probable cause to believe that the offense of a terroristic threats and possession of firearm by prohibited person has been committed.
3. That there is probable cause to believe that Daelin Collins committed said offense.
4. That Identifying Physical Characteristics Sought is/are DNA buccal swabs.
5. That Daelin Collins has refused, or there is reason to believe that Daelin Collins will refuse, to voluntarily provide the identifying physical characteristics sought.

6. That Daelin Collins is the individual who may be detained for obtaining such identifying physical characteristics.
7. That Jerad McBride and other officers of the Lincoln Police Department as well as corrections officers of the Lancaster County Jail are the peace officers authorized to obtain such identifying physical characteristics by using a reasonable amount of force and to effectuate any detention which may be necessary to obtain the same.
8. That Daelin Collins will be under no legal obligation to submit to any interrogation or to make any statement during the period of his appearance.
9. That such identifying physical characteristics may be obtained at 3801 West O ST, Lincoln, Lancaster County, Nebraska.
10. That Daelin Collins shall appear at 3801 West O ST, Lincoln, Lancaster County, Nebraska, at such date and time as is designated by Jerad McBride for the purpose of obtaining the above-mentioned identifying physical characteristics.
11. That if Daelin Collins fails to comply with the request of said Jerad McBride, the said Daelin Collins shall be guilty of contempt of court and be punished accordingly.
12. That Daelin Collins shall be required to stay no longer than one (1) hour for the purpose of Jerad McBride obtaining the above-mentioned identifying physical characteristics.
13. That this Order shall remain in force and effect for a period of fifteen (15) days only.
14. That a copy of this Order shall be served upon Daelin Collins.
15. That a Return of this Order shall be made within 30 days after the


identification procedures have been carried out, setting forth the type of identifying physical characteristics obtained. If the Order is not executed, a Return shall be filed within 30 days stating the same.

THEREFORE, you are commanded to search the said Daelin Collins to produce the aforementioned identifying physical characteristics which constitutes evidence that a criminal offense has been committed, and to seize the same.


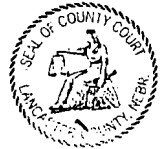

COMES NOW, Officer Jerad McBride of the Lincoln Police Department , being first duly sworn upon oath, deposes and states as follows:

1. Your AFFIANT was dispatched as the primary Ofc to investigate a terroristic threats and possession of firearm by prohibited person that occurred at 3161 Overland Trail #10 , Lincoln, Lancaster County, Nebraska on 11-24-2022.
2. Your AFFIANT has authored and reviewed reports of other peace officers involved in the investigation of terroristic threats and possession of firearm by prohibited person.

On 11-24-2022 at approximately 1552hrs, Lincoln Police Department Officers were dispatched to a belated vandalism at 3161 Overland Trail #10, Lincoln, NE. Lucille Harris reported the outer pane of glass in her walk-in door had been shattered overnight. Harris stated that her granddaughter, Jayveona Lipscomb had gotten into a fight the night before with her boyfriend, Daejon Collins, and believed he was responsible for the damage. Officers completed the call for service and left the residence at 1630hrs.

At 1635hrs on the same date, Officers were again dispatched to 3161 Overland Trail #10, Lincoln Nebraska, on a weapons violation in progress call. Brian Cal, Lucille and Jayvon Lipscomb Jr were contacted at the residence by officers, which included Ofc.M. Dirks and your

AFFIAANT. Ofc. Dirks interviewed both Brian and Lucille, however Jayvon was uncooperative. Brian stated he was outside the residence with Jayvon when an older white car pulled up in front of the residence rapidly. Brian described the driver as a black male wearing a black sweatshirt and having dreadlocks. Brian observed the driver exit the vehicle and then entered the vehicle again, appearing to reach for something. The driver exited the vehicle again along with the passenger. Brian ran into the residence and told Lucille to get down. Lucille stated she was inside the living room saw a male run up to the door with a gun, and then heard more glass breaking, referring to the front door window being vandalized. Lucille stated the gun, in which she described as grey, was pointed "right through the window" and thought he, referring to Daejon, was going to shoot. Lucille described the male holding the gun as having long dreadlocks. The male then began yelling into the residence, but she was not able to recall what was said. Lucille also recognized the voice of the male with the gun being Daejon's voice.

Officer Hite was patrolling the area of N. 33<sup>rd</sup> ST and Holdrege while other officers were still investigating the weapons call. Ofc. Hite observed a white 2006 WHI Pontiac G6 with Nebraska registration WYP774 waiting to leave the Casey's gas station located at southwest corner of 33/Holdrege. Ofc Hite researched the registration and observed the vehicle to be registered to the same address that Daejon had listed in the Lincoln Record Management System. Ofc. Hite was aware that Daejon was named as a potential suspect in the first call for service at 3161 Overland Trail #10. Ofc Hite circled around the block to contact the vehicle, which was now parked in the Kwik Shop parking lot on the southeast corner of N. 33<sup>rd</sup> and Holdrege. Ofc. Hite observed Daelin and Daejon both walking away from the vehicle into the Kwik Shop. Ofc. Hite contacted Ofc. Dirks via radio who confirmed that Daejon had been identified as a suspect and had left the scene in a white sedan with another unknown black male.

Ofc Hite made contact with Daelin in the parking lot while Daejon was still inside the gas station. Your Affiant left Overland trail to assist Ofc Hite. Your AFFIANT and Ofc. Hite detected a strong odor of burnt Marijuana coming from inside the Pontiac. Daelin was patted down for weapons and Ofc. Hite began a probable cause search of the vehicle. Ofc Hite located a loaded FMK Firearms 9mm handgun (Serial Number # SBD5566) in the center console. The gun had a magazine inserted that contained 10 rounds. Daelin was observed wearing a black hooded sweatshirt and Jeans and had short dreadlocks, which matched the driver description provided by Brian. Daejon was wearing grey sweatpants and grey sweatshirt with much longer dreadlocks, which matched the description of the party with a gun provided by Lucille. Both Daelin and Daejon were taken into custody without incident. Daelin was convicted of felony Possession of Controlled substance on 12-7-2020 CR180001036 and was prohibited from possessing firearms. Daelin denied ownership of the firearm but did not wish to make a statement. Daejon also declined an interview. Both Daelin and Daejon were cited and lodged for numerous offenses.

3. Your AFFIANT knows that buccal DNA swabs are a way of producing non-testimonial identification evidence regarding the person responsible for the terrorist threats and possession of a firearm by prohibited person described herein. The identifying physical characteristics sought from Daelin Collins is a sample of his/her DNA in the form of DNA buccal swabs. The procurement of these identifying physical characteristics is likely to contribute evidence to the further identification of Daelin Collins as being the person responsible for the terrorist threats and possession of a firearm by prohibited person herein.

The identifying physical characteristics sought can be obtained from Daelin Collins at a 575 S 10<sup>th</sup> ST, Lincoln Police Headquarters, Lincoln, Lancaster County, Nebraska and should require a detention not to exceed one (1) hour.




AFFIANT further states that there is probable cause to believe that Daelin Collins is responsible for terrorist threats and possession of a firearm by prohibited person as described herein, and in violation of the laws of the State of Nebraska.

4. Your AFFIANT has been advised that contact with Daelin Collins' attorney has been attempted but requests for consent to have buccal swabs obtained from Daelin Collins have gone unanswered. On April 23<sup>rd</sup>, 2024, at approximately 5:30 p.m., Daelin Collins was contacted at the Lancaster County Jail 3801 West O Street, Lincoln, Lancaster County, Nebraska, by Investigator Baehr #1288 with the Lincoln Police Department and he was presented with a court order signed by Judge Phillips. Daelin Collins was informed he needed to provide DNA sample through buccal swabs. Daelin Collins read a copy of the Order and stated he was not going to provide a sample. A sample was not able to be collected from Daelin Collins.

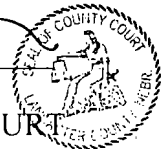


