TO: Alexander Salcedo, a Police Officer with the Lincoln Police Department, Lancaster County, Nebraska, and any and all law enforcement officers.

WHEREAS, Alexander Salcedo, has filed an Affidavit before the undersigned Judge of the County Court of Lincoln, Lancaster County, Nebraska, and said written Affidavit, having been duly considered, the court finds that the facts set forth in said Affidavit are true, and that those facts do constitute grounds and probable cause for the issuance of a Search Warrant.

THEREFORE, you are commanded to 1646 Knox Street, Lincoln, Lancaster County, Nebraska, as well as a silver 2010 Ford Fusion taxi bearing Nebraska license plates 'AFJ873', a Gray 2010 Chevrolet Traverse bearing Nebraska license plates 'YIX382' and a Gray 2006 Hyundai Sonata bearing Nebraska license plates 'ARV439' regardless of their location to the premise in Lincoln, Lancaster County, Nebraska for the following items:

All firearms, firearms, ammunition, containers or firearms related accessories and any documentation relating to the öwnership or purchase of any firearms.

Any and all controlled substance, including but not limited to marijuana; drug paraphernalia items commonly used for the ingestion of controlled substances; drug paraphernalia items commonly used for the preparation and distribution of controlled substances including, but not limited to scales, plastic bags, film canisters, tin foil, or other packaging containers such as vials and plastic wrap: any documentary evidence relating to the source of the controlled substance including, but not limited to customer lists, account sheets, ledgers, notes, or diaries; receipts; maps; cellular telephones and any other electronic storage devices that could be used in the communication and/storage of information of the sale of controlled substances; any proceeds directly attributable to the sale of controlled substances including, but not limited to United States currency, bank accounts, property, or other financial records, permission to

photograph the same; any evidence of occupancy or ownership; and authorizing and directing seizure of the same.

Law enforcement is authorized to measure, photograph, video tape, and seize the aforementioned items.

The court finds that the public interest requires that the requested search warrant not be restricted to daytime service and that it may be served at any time as firearms are accessible to the occupants and other evidence can be destroyed.

Law enforcement are not required to knock and announce their presence prior to entry.



This search warrant shall be executed and returned within ten (10) days to a Judge of the County Court of Lancaster County, Nebraska.

Alexander Salcedo, being first duly sworn upon oath deposes and states that he is an Investigator for the Lincoln Police Department, Lancaster County, Nebraska. AFFIANT further states he is currently involved in the investigation of Possession of Firearm by a Prohibited Juvenile Offender – 1st Offense 28-1204.05 and Deliver, Manufacture, Intent to Deliver a Controlled Substance, Schedule 1, 2, 3 28-416(1)(2), occurring at 1646 Knox Street, Lincoln, Lancaster County, Nebraska. As part of the investigation, AFFIANT has consulted with other involved law enforcement and reviewed case reports. AFFIANT states as follows:

Facts:

At the beginning of May 2024, investigators with the Lincoln Police Department Gang Unit began observing suspected advertisements for both guns and narcotics while reviewing the Instagram social media account of Desmond K Parks Jr (04-30-2004). The Instagram account is under the username 'dpfrmdago', herein referred to as 'the Instagram account'. Desmond K Parks Jr was observed to have posted images and videos with his face on the Instagram account as recently as May 1, 2024 and May 16, 2024, confirming the account belonged to him. It should be noted, investigators confirmed Desmond K Parks Jr's identity by comparing the Instagram photos with that of Desmond K Parks Jr's photo in the Lincoln Police Department Record Management System as well as his Department of Motor Vehicle photograph. Investigators have also had several prior contacts with Desmond K Parks Jr and are able to confirm him as being the individual in the photographs.

On May 1, 2024 a photograph was observed to have been posted to the story of the Instagram account depicting two buds of suspected marijuana with the caption, 'Onna flo'. Affiant believes this to mean prices of the marijuana advertised are low or, 'On the floor'. It should be noted, a photograph or video posted to an Instagram story can be seen by followers for a maximum of 24 hours

before being erased from the account. From Affiant's training and experience it is common for narcotic dealers to post photos of their product on their social media accounts to advertise their product for sale.

On May 16, 2024, a photograph was observed to have been posted to the story of the Instagram account in which half of Desmond K Parks Jr's face can be seen and he is observed pointing what appears to be a pistol with a green laser attachment at the camera. A digital 'Chief Keef' album cover was added to the photo and can be seen covering the barrel of the gun. The photo also has heart emojis on the bottom of the image. See Exhibit A.

On May 16, 2024 a photograph was observed to have been posted to the story of the Instagram account in which a suspected AR style rifle with a foregrip attachment can be observed on the lap of an unknown individual, but is suspected to be Desmond K Parks Jr. There is a caption on the photograph which reads 'Kome get dis 1100'. Through Affiant's training and experience, Affiant believes Desmond K Parks Jr to be advertising this AR style rifle for sale for \$1,100. See Exhibit B.

On May 17, 2024 a photograph was observed to have been posted to the story of the Instagram account depicting the inside of a vehicle that appears to be in motion with the steering wheel containing a 'Ford' emblem in view with the caption, 'Wyn'. Through Affiant's training and experience, Affiant believes this to be a narcotic advertisement meaning, 'What you need?' This can elicit responses from potential customers in which they can message narcotic dealers and advise them of specific drugs and quantities they are searching for. This photograph also confirms that Desmond K Parks Jr is utilizing a vehicle to facilitate the sales of controlled substances.

Affiant knows through training and experience that people involved in the sale of controlled substances commonly store the controlled substances as well as weapons at their primary residence. Affiant also knows that it is common for people involved in the sale of controlled substances to display their firearms on social media as a means to protect their product and proceeds by informing others they are armed.

On April 23, 2024, Desmond K Parks Jr was approved for a Taxi License in the city of Lincoln. On the application for his Taxi License, Desmond K Parks Jr provided his State of Nebraska Driver's License number, his social security number and his residential address of 1646 Knox Street, Lincoln, Lancaster

County, Nebraska. Furthermore, it was provided that Desmond K Parks Jr would be driving for Mike's Capital Cab LLC.

On May 10, 2024, Desmond K Parks Jr was contacted by Lincoln Police Investigators Villamonte #1700 and Jennings #1650 at 2291 Holdrege Street, Lincoln, Lancaster County, Nebraska. During this contact Desmond K Parks Jr was observed operating a silver 2010 Ford Fusion taxi bearing Nebraska license plates 'AFJ873'. The vehicle was also observed to have name plates on the side displaying the company name of 'Mike's Capital Cab'. Upon running the license plates, it was found the vehicle is registered to 'Mike's Capital Cab LLC'. Desmond K Parks Jr advised Investigator Villamonte #1700 that he had recently been operating the cab for business and was currently giving his friend's rides.

On May 15, 2024, Lincoln Police Investigators were in the area of 1215 Arapahoe Street, Lincoln, Lancaster County, Nebraska when they observed the same aforementioned Ford taxi cab. Lincoln Police Investigator Jennings #1650 was able to positively identify Desmond K Parks Jr as the operator of the vehicle.

It should be noted, the aforementioned Ford taxi cab has also been observed in the parking lot of 1646 Knox Street by Lincoln Police Investigators Lind #1638 and Meyer #1716 as recently as May 14, 2024; and was previously observed in the carport of 1646 Knox Street by Investigator Jennings #1650 as recently as May 9, 2024.

Per the Nebraska Department of Motor Vehicles, Desmond K Parks Jr also has two vehicle's registered in his name. On March 19, 2024, a Gray 2006 Hyundai Sonata bearing Nebraska license plates 'ARV439' was registered to 'Desmond K Parks' at an address of 1646 Knox Street, Lincoln, Lancaster County, Nebraska. This vehicle was observed in the carport of 1646 Knox Street by Lincoln Police Investigator Lind #1638 as recently as May 17, 2024.

On March 20, 2024, a Gray 2010 Chevrolet Traverse bearing Nebraska license plates 'YIX382' was registered to 'Desmond K Parks' at an address of 1646 Knox Street, Lincoln, Lancaster County, Nebraska. This vehicle was observed in the carport of 1646 Knox Street by Lincoln Police Investigators Lind #1638 and Meyer #17116 as recently as May 14, 2024. It should be noted, Desmond K Parks Jr has also previously been observed operating this aforementioned vehicle pulling into the complex of 1646 Knox Street by Investigator Villamonte #1700.

Based on the fact that the two vehicles registered to Desmond K Parks Jr as well as the cab that Desmond K Parks Jr is known to operate have all been

observed parked in the carport of 1646 Knox Street and the fact that Desmond K Parks Jr documented himself utilizing a vehicle to conduct sales of narcotics coupled with the transitory nature of both guns and drugs, Affiant believes that it is probable all three vehicles are being utilized in the commission of these crimes and probable cause does exist to search all three vehicles.

On April 20, 2022, during an unrelated investigation, Lincoln Police Investigators contacted Desmond K Parks Jr and his associate at Desmond K Parks Jr's prior residence of 1215 A Street #3, Lincoln, Lancaster County, Nebraska. During this investigation, Desmond K Parks Jr informed investigators the apartment belonged to his girlfriend whom he identified as 'Emma Smith'. On May 17, 2024 Affiant was able to verify the utilities at the residence of 1646 Knox Street, Lincoln, Lancaster County, Nebraska, is also in the name of 'Emma Smith'.

A criminal history check was conducted for Desmond K Parks Jr and he was found to have a juvenile felony adjudication for Theft by Unlawful Taking \$1,500-4,999 from December 5, 2019 where a judged advised it was unlawful for Desmond K Parks Jr to possess any firearm until age 25. Desmond K Parks Jr is currently only 20 years old.

The residence of 1646 Knox Street, Lincoln, Lancaster County, Nebraska is a single-family residence located in multi-unit building that runs east to west and is located on the north side of Knox Street. It is a two-story building with the upper half being white and the lower half green. The building contains six units that are attached, but not accessible to each other. The residence of 1646 Knox Street is the third unit from the east with a carport and door facing south towards Knox and the numbers '1646' posted in silver color on a green wall to the right of the carport.

The above does constitute grounds of probable cause for the issuance of a Search Warrant for 1646 Knox Street, Lincoln, Lancaster County, Nebraska, as well as a silver 2010 Ford Fusion taxi bearing Nebraska license plates 'AFJ873', a Gray 2010 Chevrolet Traverse bearing Nebraska license plates 'YIX382' and a Gray 2006 Hyundai Sonata bearing Nebraska license plates 'ARV439' regardless of their location to the premise in Lincoln, Lancaster County, Nebraska for the following items:

All firearms, firearms, ammunition, containers or firearms related accessories and any documentation relating to the ownership or purchase of any firearms.

Any and all controlled substance, including but not limited to marijuana; drug paraphernalia items commonly used for the ingestion of controlled substances; drug paraphernalia items commonly used for the preparation and distribution of controlled substances including, but not limited to scales, plastic bags, film canisters, tin foil, or other packaging containers such as vials and plastic wrap: any documentary evidence relating to the source of the controlled substance including, but not limited to customer lists, account sheets, ledgers, notes, or diaries; receipts; maps; cellular telephones and any other electronic storage devices that could be used in the communication and/storage of information of the sale of controlled substances; any proceeds directly attributable to the sale of controlled substances including, but not limited to United States currency, bank accounts, property, or other financial records, permission to photograph the same; any evidence of occupancy or ownership; and authorizing and directing seizure of the same.

AFFIANT requests authorization to measure, photograph, video tape and seize the aforementioned items.

Based on aforementioned information and past criminal investigations and that Desmond K Parks Jr is in possession of multiple firearms law enforcement is asking for flexibility to serve the warrant anytime of the day or night in order to safely serve the warrant for all involved, including the community, law enforcement and occupants of 1646 Knox Street.

Your Affiant further states that if the officers announce their presence and knock prior to their entry into 1646 Knox Street, Lincoln, Lancaster County, Nebraska, the property sought poses danger to life or limb of the officers or others may result. Specifically, your Affiant states that: The aforementioned firearms could be accessed and readied by individuals inside the residence if announcements are given.




