Christopher Schamber, being first duly sworn upon oath deposes and states that he is a Investigator for the Lincoln Police Department, Lancaster County, Nebraska. AFFIANT further states he is currently involved in the investigation of two counts of Murder, 1st Degree under State Statute 28-303 (Class 1A Felonies) and two counts of Use of a Firearm to commit a Felony under State Statute 28-1205 (Class 1C Felonies), occurring at 640 W Prospector Ct, Lincoln, Lancaster County, Nebraska. As part of the investigation, AFFIANT has consulted with other involved law enforcement and reviewed case reports. AFFIANT states as follows:

### Facts:

On 05-25-2024 at 0159 hours, Officers of the Lincoln Police Department were dispatched to 640 W Prospector Court, The Office Gentlemen's Club, on the report of a shooting which had just occurred. Dispatch advised that there were two males who had been shot. When police officers arrived, they found the first male victim to be unresponsive with multiple gunshot wounds located about 10 feet from the front entrance of the business. Numerous shell casings were located near the entrance of the building. A white hat with a baggie containing a white powdery substance was located on the sidewalk near the shooting victim. The first shooting victim was transported by ambulance and was later pronounced deceased at Bryan West Hospital. The first shooting victim was identified at the hospital as Terrell L. Jones, DOB:12-31-1983.

At the scene, Police Officers were also directed inside of The Office Gentleman's Club where they located a second shooting victim, who was later identified as Carlos L. Silva, DOB:5-24-1985. Silva was located inside the business near the North side back exit door of the building. Silva was responsive and was

C4-045095 Affidavit Page 1 of 5 bleeding from a gunshot wound. Silva was transported by ambulance to Bryan West hospital and was later pronounced deceased from his injuries. A bag of marijuana was located on Silva's person.

Your affiant is aware that a suspect matching the description of Christopher Z. Johnson, DOB:12-13-91, is observed on surveillance video from The Office Gentlemen's Club shooting at the two victims with a firearm. Your Affiant has reviewed the surveillance video and states that prior to the shooting, Johnson and another male matching the description of Darious D. Fletcher DOB: 04-30-1992, meet in the parking lot of the business in the front seat of what appears to be Johnson's silver 1997 Mercury Grand Marquis. Johnson can be observed on the video pulling a handgun from underneath the driver's seat as he and Fletcher continue to converse. Shortly after, Fletcher appears to be talking with Jones as Jones is seated in a black Jeep in the parking lot in front of the front door of The Office Gentlemen's Club. Johnson stands near the front entrance of The Office Gentlemen's Club and shortly after begins conversing with Silva. Johnson then shoots Silva several times. Johnson then turns and shoots several times at Jones in the black Jeep as Fletcher is backing away. Johnson continues shooting several times at Jones while Jones is attempting to get away from Johnson. Johnson then hands the handgun to Fletcher. Fletcher then gets into the driver's seat of what appears to be Johnson's Mercury Grand Marquis. On the video, the firearm can clearly be observed in Fletcher's right hand as he is seated in the driver's seat. Johnson walks around the back of the vehicle and gets into the passenger seat. Fletcher then drives the 1997 Mercury Grand Marquis away from the scene with Johnson in the passenger seat.

Your affiant has continued to review surveillance video from the The Office Gentleman's Club during this investigation and is aware that at the time of the shooting, Christopher Z. Johnson is wearing a blue and white hat, a blue T-shirt with a design on it, orange shorts and dark blue colored athletic shoes with an orange toe box. Further review of the surveillance images taken from inside The Office Gentleman's Club shows that Christopher Z. Johnson is wearing jewelry, including rings on his fingers. Christopher Z. Johnson also appears to have an orange satchel over his shoulder. The male matching the description of Darious

Fletcher is also wearing a similar outfit, including a blue t-shirt, orange shorts with blue and orange shoes. The sedan which left the scene of the shooting matches the description of a silver, 1997 Mercury Grand Marquis with NE license plate ASA661, which is registered to Christopher Z. Johnson.

Your affiant is aware that electronic surveillance in the area of 629 S. 19<sup>th</sup> St shows a silver sedan matching the description of a Mercury Grand Marquis arriving at 629 S. 19<sup>th</sup> St at approximately 0203 hours on 5-25-2024. A male matching the description of Christopher Z. Johnson is observed exiting the passenger side of the Mercury Grand Marquis and entering the backdoor of 629 S. 19<sup>th</sup> St. A male then leaves 629 S. 19<sup>th</sup> St approximately 13 minutes later and gets into a Black Tahoe and leaves Northbound on S. 19<sup>th</sup> St. Investigators at the residence observed what they identified as a surveillance camera above the garage of 629 S. 19<sup>th</sup> St.

Your Affiant is aware that Sergeant Sorenson and Investigator Lind, upon reviewing surveillance images from 640 W Prospector Court, were able to positively identify the suspected shooter as Christopher Z. Johnson, DOB:12-13-1991, a person they are familiar with in their roles as Investigators with the Lincoln Police Department Gang Unit.

Your Affiant is aware that there are reports with the Lincoln Police Department from 07-12-2022 indicating that Christopher Johnson is involved in the selling and using of Narcotics.

Your Affiant is aware that Christopher Z. Johnson and Darious D. Fletcher have been reported to have been involved in a shooting together on 07-28-2013 reported under Lincoln Police Department case number B3-067740.

Your Affiant is aware that on 05-28-2024, Investigators met with an informant who is willing to testify and is known to law enforcement. The informant has known Darious Delas Fletcher for the past twenty years and has had hundreds of contacts with him during this time span. The informant was shown still photographs of images of the male party who was with Christopher Johnson taken from inside The Office Gentleman's Club just prior to the shooting. The informant stated that they were 100 percent positive that the male party from the surveillance video still photographs is Darious Delas Fletcher. The informant identified the image as 'Darious Delas Fletcher'. Your affiant is aware that the individual which was identified as Darious Delas Fletcher by the informant is the same individual who is later given the firearm by Christopher Johnson after the

shooting and then drives the Grand Marquis, with Christopher Johnson as the front seat passenger, away from the scene.

On 05-28-2024 at 1921 hours, your Affiant is aware that Investigators located Darious Fletcher at 1425 S 10<sup>th</sup> Street and took him into custody. A search warrant was executed at 1425 S. 10<sup>th</sup> St #4 and during the search, orange shorts, a blue t-shirt with a design on it and blue Nike shoes with an orange toe box were located. These clothing items match the description of the clothing which was worn by both Christopher Johnson and Darious Fletcher during the shooting at The Office Gentleman's Club on 05-25-2024.

Your affiant is aware that also on 5-28-2024, Christopher Johnson was located and arrested by Investigators in Omaha, Nebraska and taken to the Douglas County Department of Corrections, located at 710 S. 17<sup>th</sup> St, in Omaha, Nebraska.

Your affiant is aware that on 5-29-2024 Christopher Johnson and the items he had in his possession at the time of his arrest in Omaha, Nebraska, were transported by law enforcement officers from the Douglas County Department of Corrections to the to the Lancaster County Department of Corrections, located at 3801 W O St, Lincoln, Lancaster County, Nebraska.

On 05-29-2024 at 1428 hours, your affiant went to the Lancaster County Department of Corrections located at 3801 W O St, Lincoln, Lancaster County, Nebraska and inspected the property for Christopher Z. Johnson which had been transported along with Christopher Z. Johnson from the Douglas County Department of Corrections at 710 S. 17<sup>th</sup> St, in Omaha, Nebraska. Upon review of the property, your affiant observed a pair of blue and orange Nike shoes, with an orange toe box, men's size 13, in the inmate property for Christopher Johnson. These shoes match the description of the shoes that Christopher Johnson was wearing during the shooting. Your affiant also observed jewelry in the inmate property for Christopher Johnson as well.

The above does constitute grounds of probable cause for the issuance of a Search Warrant at the Lancaster County Department of Corrections, located at 3801 W O St, Lincoln, Lancaster County, Nebraska, for the following items:

-rings and jewelry located in the inmate property for Christopher Z. Johnson, DOB:12-13-91
