WHEREAS, Patrick Sullivan, has filed an Affidavit before the undersigned Judge of the County Court of Lincoln, Lancaster County, Nebraska, and said written Affidavit, having been duly considered, the court finds that the facts set forth in said Affidavit are true, and that those facts do constitute grounds and probable cause for the issuance of a Search Warrant.

THEREFORE, you are commanded to search 1706 Normandy Circle Apartment #2 which is a two-story split-level apartment complex. The apartment is located on the main level and its door is brown with a metal number two attached to the front of the door, located in Lincoln Lancaster County, Nebraska, for the following items:

-Black Hoodie with a bear design that has two xs for eyes, Black hoodie, Red hoodie with, American flag in the middle back, White ski mask, Pink ski Mask, White gloves, Blue and Orange backpack, Black and White ski mask, Black gloves, Two pairs of white and black shoes

-US Currency

-Vape Products

- All firearms, ammunition, casings, containers, or firearms related accessories and paperwork and receipts for firearms and related firearm accessories


- Proof of occupancy or residency.

Law enforcement is authorized to measure, photograph, video tape, and seize the aforementioned items.


The court finds that the public interest requires the Search Warrant be served at any time of the day, including nighttime hours.

Patrick Sullivan, being first duly sworn upon oath deposes and states that he is a Investigator for the Lincoln Police Department, Lancaster County, Nebraska. AFFIANT further states he is currently involved in the investigation of ROBBERY 28-324 (F2), occurring on June 10, 2024, at 1421 Center Park Road, Lancaster County, Nebraska. As part of the investigation, AFFIANT has consulted with other involved law enforcement and reviewed case reports. AFFIANT states as follows:

Case Facts

On June 10, 2024, Officers with the Lincoln Police Department were dispatched to 1421 Center Park Road on the report of a robbery that had just occurred. Officers contacted Natalie Vesterfelt who stated she is the manager of the U-Stop gas station. Natalie stated her employee, Victor Tran was robbed at gunpoint by 4 juveniles. Officers contacted Victor inside of the U-Stop. Victor said he was working in the backroom when he heard the front door of the gas station open. Victor said he proceeded to the cash register where he discovered 4 juveniles that he thought were just normal customers. Victor said once he was behind the counter, the 4 juveniles approached him and one male pointed a brown and/or silver handgun at him. Victor said the male yelled at him to open the drawer and get all the money and to hurry. Victor said he was scared during the incident because he did not want to get shot. Victor said while he was handing over the money from the cash register, the female grabbed several vape products on display at the front counter and put them in a bag. Victor said once he handed over approximately \$200 in US currency to the male; they all ran out the door and split up, but ultimately all fled on foot southbound from the gas station. Victor also said that there were no other customers inside the store during the incident. Security footage was collected from the U-Stop which shows a male wearing a

black hoodie with a bear design with 'xs' for eyes on the front, a black and white ski mask, and white and black shoes, point a handgun at Victor. Another person is seen wearing a white ski mask, black hoodie, and white and black shoes. This person is also holding a blue and orange backpack. The third person is seen wearing a red hoodie with an American flag in the middle of the back, and a pink ski mask.

On June 9, 2024, Ana M Simic reported that her white 2015 Subaru, license plate T0MIS was stolen from her open garage at 8615 Peregrine Court, Lincoln, Lancaster County, Nebraska.

On June 10, 2024 at approximately 1632 hours, a caller told dispatch that a white Subaru bearing the plate T0MIS was dropped off by three juvenile males and one juvenile female in the area of 1706 Normandy Circle, Lincoln, Lancaster County, Nebraska. Investigator Johnson #1736 and Investigator Buhrman #1828 were in an unmarked vehicle watching the Subaru. At approximately 1655 hours, three juvenile males and a juvenile female were seen walking toward the vehicle. Investigator Johnson and Buhrman got out of their vehicle and identified themselves as law enforcement. All four juveniles took off running and were apprehended by law enforcement, taken to the Hall of Justice, and placed in interview rooms. These four were Jovani Loving (DOB: 04-28-09), Brandon Rothwell (DOB: 04-25-2008), Travon Gadara (DOB: 02-07-2008), and Breanna Rothwell (DOB: 06-03-2010).

Investigator Johnson spoke with Jovani who was read his Miranda Rights and waived them. Jovani stated Brandon, Travon, and himself were all together before the robbery, but he would not say who all went inside the U-Stop. When Jovani was placed into custody he was wearing a black and yellow glove which is the exact kind that can be seen on the U-Stop security cameras.

Officer Sims #1835 got permission from Breanna's father, Bryan Rothwell to interview Breanna. Officer Sims also read Breanna her Miranda rights and she waived them. Sergeant Tran #1669 spoke with Breanna in the presence of Bryan. Breanna said Jovani, Brandon, and Travon planned the robbery. Breanna said Jovani was the one holding the firearm, while the party stuffing items into a backpack; and Brandon was holding the door. Breanna said the items taken from

the robbery would be located at Jovani's residence in a drawer in his bedroom. Jovani is listed in the LPD records management system as living at 1706 Normandy Circle Apartment #2.

Your Affiant read Brandon his Miranda rights and he waived them. Brandon said the items stolen from the robbery would be located in Jovani's room in a red shoebox. Brandon said the shoebox would be in a dresser drawer in the bottom right drawer. Brandon said Travon bought a vape from him and Travon told him these items were stolen from the robbery. Sergeant Tran then spoke with Brandon who admitted he was actually involved in the robbery.

Your Affiant states that it is approximately 9:00 p.m. at the time that this Affidavit for Search Warrant is being drafted. Night time is upon us and the public interest requires that the requested search warrant not be restricted to daytime service and that it may be serve any time for the following reasons: The apartment has already been cleared and secured by law enforcement.

1706 Normandy Circle Apartment #2 can be described as a two-story split-level apartment complex. The apartment is located on the main level and its door is brown with a metal number two attached to the front of the door

The above does constitute grounds of probable cause for the issuance of a Search Warrant for 1706 Normandy Circle Apartment #2, Lincoln, Lancaster County, Nebraska, for the following items:

- Black Hoodie with a bear design that has two xs for eyes, Black hoodie, Red hoodie with, American flag in the middle back, White ski mask, Pink ski Mask, White gloves, Blue and Orange backpack, Black and White ski mask, Black gloves, Two pairs of white and black shoes

- US Currency

- Vape Products


