Chad Baehr, being first duly sworn upon oath deposes and states that he is a Investigator for the Lincoln Police Department, Lancaster County, Nebraska. AFFIANT further states he is currently involved in the investigation of Theft by Receiving Stolen Property \$5,000/More 28-517(F2A), occurring at North 31st and S Street, Lancaster County, Nebraska. As part of the investigation, AFFIANT has consulted with other involved law enforcement and reviewed case reports. AFFIANT states as follows:

Facts:

Affiant has read the reports and assisted with the investigation of an auto theft occurring at 6100 O Street, Lincoln, Lancaster County, Nebraska which was then involved in an accident at N. 31st and S Street, Lincoln, Lancaster, County, Nebraska occurring on May 5th, 2024, where a Nathan T. Thomas, White Male, DOB: 10-19-2005 was identified as fleeing from the stolen vehicle after the accident and has since been arrested.

On May 5th, 2024, at approximately 12:26 p.m., Office Rensch #1740 and Officer Wolbert #1513 with the Lincoln Police Department, Lincoln, Lancaster County, Nebraska, were sent to the intersection of North 31st and S Street, Lincoln, Lancaster County, Nebraska on an accident between a white pickup and red 2018 Kia Sportage with Nebraska Plate number 16-L931. While officers were on there way there they were informed by dispatch that 2 individuals from the Kia involved in the accident was running from the scene. Officer Rensch arrived on

scene and through the course of his investigation discovered the 2018 red Kia had been stolen from 6100 O Street, Lincoln, Lancaster County, Nebraska sometime after 11:50 a.m. on the same date. The value of the stolen vehicle is estimated at \$5,000.00.

Officer Rensch determined that the Sacred Heart of Jesus Catholic Church located at 3128 S Street, Lincoln, Lancaster County, Nebraska, had video surveillance covering the area and captured the accident and the suspects running from the scene. Officer Rensch reviewed the video which showed the accident. Video showed as soon as the red Kia comes to a stop a white male juvenile wearing a black hooded sweatshirt with a 'white Native America Feather' on the front and 'Cow Skull with the number '600' on the back of it, grey pants and red shoes gets out of the driver's front seat and runs southbound a short distance. He is observed in the video bleeding from the head as he is running away. The same juvenile then returns to the vehicle and eventually another juvenile, wearing all black, gets out. Both juveniles then flee the scene northbound on North 31st Street past the church and out of camera view. Still photos of the juveniles running from the accident were sent to the Lincoln Police High School Resource Officers to attempt to identify the juveniles.

On May 9th, 2024, Lincoln Police School Resource Officer Dostal #1773 with the Northeast High School, Lincoln, Lancaster County, Nebraska, reviewed the images and video of the 2 juveniles running from the stolen vehicle after it was involved in the accident. Officer Dostal identified, with 100% certainty, the juvenile wearing the black hoodie sweatshirt, grey pants and red shoes as Nathan Thomas, White Male, DOB: 10-19-2005. Officer Dostal showed the video to Zachary Fleer, Administrator at Northeast High School, who also identified the juvenile as Nathan Thomas.

On May 13th, 2024, Officer Rensch contacted Thomas's mother, Kerstin Nuss, at their residence of 7105 Francis Street, Lincoln, Lancaster County, Nebraska. Officer Rensch informed Kerstin that her son needed to be arrested regarding being in a stolen vehicle and then leaving the scene of an accident after he wrecked it. Kerstin made comments that her son does live with her but was currently not home. Kerstin stated her son had an injury to his head and received medical treatment for it. Kerstin stated she did not know what happened to her son's head.

On May 13th, 2024, at approximately 7:40 p.m., Thomas turned himself at the Lancaster County Jail at 3801 West O Street, Lincoln, Lancaster County, Nebraska. Thomas was cited and lodged for Theft by Receiving Stolen Property \$5,000/more 28-517(F2A).

The above does constitute grounds of probable cause for the issuance of a Search Warrant for 7105 Francis Street which is a tan brick house with brown trim with a front porch facing Francis Street with a chain linked fence surrounding it located in Lincoln, Lancaster County, Nebraska, for the following items:

- -Black Hooded Sweatshirt with a white "Native America Feathers" emblem on front and a 'Cow Skull and 600' on the back.
- -Red Shoes
- -Grey Pants
