Joseph Fisher, being first duly sworn upon oath deposes and states that he is a Police Officer for the Lincoln Police Department, Lancaster County, Nebraska. AFFIANT further states he is currently involved in the investigation of City Ordinance 10.42.110 Keeping of Unregistered, Wrecked or Junked Vehicles, occurring at 5700 Saylor St., Lincoln, Lancaster County, Nebraska.

Facts

On April 1, 2024, Lincoln Police Department Public Service Officer Michael Schaaf #764 was detailed 5700 Saylor St., Lincoln, Lancaster County, Nebraska on a complaint regarding junk vehicles, a 2002 White Ford Focus expired Nebraska license plate VTP006 (11-2021), and a 2003 Blue Ford Edge expired Nebraska license plate UIB033 (4-2023) that were parked in a drive way to 5700 Saylor St accessible off of S. 57th St. PSO Schaaf placed parking citations on these two vehicles along with a junk vehicle flyer explaining the city ordinances regarding these vehicles and requested them to call him giving them a compliance date of May 1st, 2024. PSO Schaaf made contact with the homeowner, Richard Laws on April 3, 2024 and asked him if he had received the notice and he stated he had. On May 2nd 2024, PSO Schaaf drove by 5700 Saylor St. and the vehicles had not moved or been registered with the state of Nebraska.

On May 4th, 2024 your Affiant drove by 5700 Saylor St. and observed the White Ford Focus was being towed from the property. Your Affiant made contact with Richard Laws and asked what he had planned to do with the Blue Ford Edge. Richard stated they had planned on having the car removed, but had not arranged it yet. Your affiant requested Richard contact him when this had been

arranged with in the next five days. On May 7th, 2024 your Affiant again drove by 5700 Saylor St. and observed the Blue Ford Edge to still be in the driveway missing its rear passenger's wheel. Your Affiant checked for a hobbyist permit to be issued to 5700 Saylor St. and found that none had been issued as of May 7th, 2024.

The above does constitute grounds of probable cause for the issuance of a Search Warrant for 5700 Saylor St., Lincoln, Lancaster County, Nebraska, for the following items:

Blue 2003 Ford Edge, Nebraska License Plate, UIB033 expired 4/2023, VIN: 1FMYU93193KB34414 located on the property at 5700 Saylor St. accessible by a driveway located on S. 57th St. Lincoln Lancaster County, Nebraska
